

Notes from the Podium – President's Message

Happy New Year to everyone and I hope each of you were able to enjoy the holidays with loved ones and friends. Sometimes we need to stop the everyday worries and just kick back and enjoy – drink that extra beer, eat that turkey leg, and all the pumpkin pie you can hold. You can now start the new walking or jogging campaign to get rid of the extra pounds.

2013 is shaping up to be a challenging year and we can divide ourselves into one of two camps: Some of us can listen to all the news and discussion about action to control violence, verbally complain to all within reach, and then <u>do nothing</u>; while others can listen to all the news and discussion about actions to control violence, <u>form our own opinions</u>, and <u>convey them to our elected officials in writing, giving our names, addresses, email addresses</u>, and phone numbers. The first group is very willing to allow others to carry on the fight for fair treatment of gun owners and shooters, while standing on the sidelines.

Show & Tell for the December 13th Meeting: As is often the case when we have a well attended meeting, we had a pretty good show and tell. **Member 1** brought two black powder flintlocks. The first was an 1803 Harper's Ferry rifle in .54 caliber. This gun was the 2nd variation made with a 36" barrel in 1819 and used pins to secure the barrel instead of bands. He then showed a reproduction Scottish flintlock pistol with belt hook and a full metal handle that resemble ram's horns. Made of totally bright metal as the originals, these are attractive historical flintlocks. **Member 2** showed a rare S&W single shot target ;pistol, the 1st Model of 1891, which was made from 1893-1905. Well known for accuracy, a version of this pistol was used in the 1906 Olympics. Member 3 showed an unusual variation of an AR-15 with a blue receiver designating is cannot be used to fire live projectile ammunition. This was evidenced by the absence of a bore in the barrel. It was designed as a blank firing device. **Member 4** showed a rare (in the U.S.) German silhouette pistol made by Rhöner Sportwaffenfabrik GmbH. It was imported by Beeman, but only 15 guns made it into the US before it was discontinued. Member 5 showed an unusual design Stevens 20 guage pump shotgun made in the 1920's. When the gun fires, the barrel moves forward to pick up a new round. Takedown required a proprietary spanner that was stored in the barrel magazine. The gun was made obsolete with the appearance of the new Winchester Model 12 shotgun. Member 6 showed some demilled, inert 40mm rounds used in the WW2 ship-borne Bofors automatic twin antiaircraft cannons. The rounds came in clips of 4 and were dropped into the feed slot of the cannons, also referred to as 'pom-pom' guns, which are familiar to anyone watching a WW2 Navy movie or news reel. Member 7 showed a project he has been working on to design a scope mount for the FN-49 rifles. Original rifles could have a scope mounted using a special mount provided by FN, however the mounts are very rare, expensive, and seldom seen. Member 8 showed a Remington Rolling Block Cadet Rifle mad from a Remington 1867 pistol action. Known as the Pistol-framed Cadet Rifle, it was chambered in .50 Remington Pistol Centerfire. It was intended for sale to military schools and boys cadet corps. The last items was displayed by **Member 9**. It was a wall hanger flintlock pistol in .43 caliber. It is thought to have been made by John Williams of Georgia and has a nice curly maple stock. Part of a matched set, its mate was lost during Sherman's March to the Sea.
