Presentation for the April 25, 2013 Meeting: There was no formal presentation at the April meeting.

♥ Presentation for May 23, 2013: John E. McCullough, Esq., a new member of VGCA, will present an overview of "Gun Trusts" and the applicable laws such trusts are intended to address. He will cover how important it is for every law-abiding gun owner or collector to stay abreast of all the complex and evolving gun laws. For instance, possession and transfer of any type of firearm to a "prohibited person" could result in a <u>felony</u>? If you own "NFA firearms," allowing others access to them, can create legal risks that you can avoid. Since certain firearms and accessories are restricted by federal, state and local laws, and there are many regulations and issues surrounding the passing down of guns to one's heirs or purchasing NFA firearms without the consent of a local chief of police, and it takes careful planning. Come out to hear more in his talk of these and other planning issues. Added bonus: Food will be served, so arrive early or risk an empty plate.

Are Members Interested in New VGCA Table Covers? Jim Burgess has been researching the availability of



table covers for members to sue at our guns shows or in their collection or reloading rooms. He has received a price quote from Showcase Exhibits in Manassas that reflects a price of \$149.00 for a group order of no less than 30 covers. A shipping charge of \$6.00 is tacked on to the above price so the net price per cover is actually \$155.00. To get this price the VGCA logo will have to be one color (gold) but the base color can vary (blue, green, etc.) in the order and still receive the group rate. Those interested will need to specify their choice of background color based on the options shown on the Showcase Exhibits website (www.showcaseexhibits.com). The default color will be royal blue which appears

closest to the previous covers. (See image *above* – note: **Image from existing covers is 2 colors – gold and black, new image will be a single color**) Delivered price will be \$155 provided there is sufficient interest for more than 30 table covers. VGCA Limited Edition Henry Arms .22 Golden

Boy Rifle: The VGCA has been exploring the possibility of having a VGCA Limited Edition Henry Repeating Arms Goldenboy lever action rifle in .22LR. The rifle in question can be viewed at http://www.henryrepeating.com/rifle-goldenboy.cfm.



Member John Isoldi has contacted Henry Repeating Arms and has secured their agreement to produce a limited run of these rifles for VGCA members. The rifle would feature the VGCA name and logo laser engraved into

the stock and have a special series of VGCA-specific serial numbers. The rifle, which has an MSRP of \$515 for the standard product, would be available to VGCA members for \$380. In order to receive this pricing and the unique features, we need to have a minimum of 30 paid commitments for a rifle.
