

# October 2013 VGCA e-Newsletter



Presentation from the September 26, 2013 Meeting: VGCA member and Director Marc Gorelick covered U.S. MILITARY **REMINGTON ROLLING BLOCK PISTOLS -** One Step Forward and Two Steps Back. This presentation examined a unique chapter in the history of U.S. martial firearms by covering the background, history, use and specifications of the three Rolling Block Pistols adopted by the US Navy and US Army in the post-Civil War years. Marc began by providing and overview of the pistols that he would cover. Although many collectors feel the three models of single-shot Remington Rolling Block military pistols produced for the U.S. Army and Navy after the Civil War are among the most elegant and graceful military pistols, due to the advent of revolvers and the self-contained metallic cartridge for small arms, they were obsolete before they were designed and single-shot military pistols were being abandoned worldwide. While the U.S. Army and Navy knew that single shot pistols were obsolete, both services ordered and used Remington Rolling Block single-shot pistols after the Civil War. During the Civil War the U.S. Navy became very interested in self-contained cartridges since in sea

operations percussion guns would fail to fire due to damp powder or paper cartridges, plus there was the danger of igniting loose gunpowder or paper cartridges. After the war, the U.S. government was in no hurry to begin purchasing new firearms due to politics, a supply of obsolete weapons, and military budget cuts.

In this environment, Remington produced the three Army and Navy models of Remington Rolling Block pistols, the Model 1865 Navy, the Model 1867 Navy, and the Model 1871 Army. All three were strong, reliable, and fired a .50 caliber metallic cartridge. The Navy's choice included having a very favorable experience with the Remington Rolling Block (RRB) system for small arms. Marc showed the RRB was a refinement and improvement over the Remington Split Breech Action designed by Leonard Geiger that was used in the Civil War. The patents of Joseph Rider improved the action by strengthening and simplifying the manufacture of the new action. The Geiger and Rider patents saved Remington and the resulting system had only two major moving parts – the hammer and rolling breech block. In June 1866, the Navy contracted for 5,000 Navy Model 1865 Pistols and by 1869 had ordered another 8,000. 500 were also made for civilian use. These were chambered in .50 Caliber Rimfire with an 8.5" barrel and a distinctive spur trigger. Due to problems with the 1865 Model, the Navy Model 1867 Pistol was developed. It was not a newly manufactured gun, but was an altered and improved Model 1865. There were 3 major alterations and it took 5 years to convert 5,358 pistols. This 1867 Model and the original 1865 model received hard, heavy use around the world and were used in the battles on the Korean peninsula. Many that survived were later sold by the Navy and altered to target pistols. In addition, many were also converted to Remington Cadet Rifles. Marc showed an M. Hartley & Co. 1903-1904 Catalogue that featured a rifle based upon the .50 caliber Remington Model 1865/1867 pistol action selling for \$6.00. For this reason it is very hard to find guns in original configuration. The U.S. Army used the Model 1871 RRB Pistol in .50 Caliber Centerfire. Changes included: the trigger and trigger guard; adding a spur to the rear of the receiver to allow for a better grip; re-contouring the grip; changing the firing pin and extractor; changing the front sight to a blade; and redesigning the lockwork. It had an 8" round barrel, casehardened frame and trigger guard, and bright hammer and

breechblock. 1,377 were issued to troops for field trials in 1871-1872, and later saw Indian War service. They were later sold as surplus and many were converted to target pistols. Approximately 900-1,000 civilian models were sold. Marc also covered the .50 caliber Remington Pistol ammunition which was the first self-contained metallic pistol cartridge. It was a short stubby cartridge made in both rimfire (M1865) & centerfire (M1867 & 1871) and fired a 300 grain bullet over 25 grains of black powder for 600 fps muzzle velocity generating 240 foot pounds muzzle energy. After a Q&A period, members were invited to examine the pistols using the white cotton gloves to prevent corrosion to the finishes. Reports show the program was very well executed and popular with attendees.

This is especially important with the new restrictive Maryland laws going into effect October 1. It is your responsibility to ensure you are obeying the law and to avoid any activities that could put you at risk or discredit the Association.

The November show has sold out all tables. There are 5-6 people on a waiting list. We are only using one building. Sam Hatfield has sales tables but will not be setting up his shooting gallery. We will be using one of the new ticket booths at the Fairgrounds entrance gate which will have two ticket purchase points. <u>Note: the gate</u> <u>fee for admission will increase to \$7 at the show in November</u>. This is still a bargain in this world of \$10, \$12, and \$13 show admissions, especially since many shows are not solely firearms and firearms related. Virginia gubernatorial candidate Terry McAuliffe's (D) website was updated Monday to show his commitment to bring Colorado-like gun control to the Commonwealth.

In the section titled "Investing in Virginia's Urban Centers," TerryMcAuliffe.com now contains the heading, "Support Common Sense Gun Control Measures."

Under that heading, it says McAuliffe "will support mainstream and majority supported gun control measures like universal background checks, limiting the size of magazines, and a return to the 1-gun-per-month rule."

The limitation on magazine capacity is a Colorado-like gun control measure that will put law-abiding Virginians at a disadvantage the moment it is enacted. This is because criminals will not obey it but will keep their "high-capacity" magazines so they can outgun their victims.

Universal background checks will mean an end to private gun sales in the state of Virginia, as they did in Colorado. This happens because Virginians will have to get the government's permission, via a background check, in order to sell or buy a firearm.

In addition, the universal background check mechanism will allow a McAuliffe governorship to control how many guns Virginians can or cannot buy each month — thus the pledge to "return to the 1-gun-per-month rule."

Once similar gun control measures passed in Colorado, upset citizens successfully recalled two State Senators behind the legislation within months.

**The Election of VGCA Officers for the 2014-2016 Term.** This is a request to get members thinking about the Annual Association Membership Meeting in early December. As last time, we will be taking nominations from the floor at the December meeting for candidates for the offices of President, Vice President, Secretary and Treasurer. The December Annual Membership Meeting is the only opportunity you may have to question potential candidates about their ideas for the direction of the Association, instead of relying on a photo and one paragraph attachment to the ballot. Some of the incumbent Officers have indicated they are <u>not</u> running for re-election, so we will need to have candidates to fill the vacant positions. Please consider if you would like to run, or if you have someone you would like to nominate to run. Our recent elections have had increasing interest and candidates, and we have been busy recruiting and signing up new members, which is a good sign.

**Show & Tell at the September 26, 2013 Meeting**: In keeping with the subject matter of the evening's presentation, **Member 1** showed 5 Remington Rolling Block (RRB) pistols from the collection of a fellow VGCA member. 4 of the 5 pistols were private gunsmith conversions of military pistols, while the fifth was a Remington Factory conversion of a military pistol. Among the conversions by gunsmiths was a rare and beautiful Arthur Hubalek custom conversion of a Model 1871 Army in .22RF from the 1940's. Hubalek, a jeweler by trade was also a noted gunsmith, barrel and scope maker, and Schutzen shooter. He used to be a friend of Pope until he learned Pope's secrets of barrel making and became Pope's competitor. The Remington Rolling Block Model of 1887 in .22 short from the collection was based on the Navy Model 1867 and is an excellent example of Remington using leftover parts from a military contract to produce a high quality target pistol. **Member 2** presented a German P-38 pistol with a Swedish holster. **Member 3** showed a rare CZ-46 pistol with Czechoslovakian markings. These pistols, which look like a Walther P-38, were assembled after the Second World War from German P-38 parts and included a number of improvements made by the Czechs. Only a few thousand were manufactured. The last item, displayed by **Member 4**, was a high-grade 12 gauge side-by-side percussion shotgun with vividly patterned Damascus steel barrels, ornate engraving and inlaid gold embellishments. It was marked on the barrel rib with the name Gasser, an Austrian gun maker associated with Austro-Hungarian revolvers like the Rast-Gasser. Leopold

Gasser began making firearms in the mid-1800s, and though he died in 1871 his company was successfully continued on by his son Johann. As Gasser is not known to have manufactured shotguns, this piece is most likely a custom item commissioned for one of the Gassers.
