Wilde Drop Forge and Tool Company

Gary is the author of <u>American Bayonets of the 20th Century</u>: following is information that he learned after the book was published. Ed.

The company was started in circa 1927 by Otto P. Froeschl and Paul Froeschl (brothers) at 27th and Fairmont in Kansas City Missouri. One source states it was named for Henry Wilde (pronounced Wild-ee) who provided the startup financing. Paul's sons Paul Jr. and Phil took over the company in the 1950s. Floods in 1953 and 1954 damaged the plant, and it has since moved to Hiawatha, Kansas and is still in business today.

Purchase order #870 was issued for 60,000 M1905 bayonets to Wilde Drop Forge and Tool Company on September 27, 1941 at a price of about \$3.34 per bayonet. This is based on the \$200,000 contract amount as shown in the Alphabetical Listing of Major War Supply Contracts and confirmed by the Register of Prices Paid for Small Arms Items dated August 20, 1942. This was a considerably lower price than was paid to the other contractors, most of who received about \$4.00 per bayonet.

As with all the makers, Wilde had great problems in starting production, both in obtaining the proper steel and in heat treatment. Although it was planned for deliveries to begin in late 1941 or early 1942 and to be completed by June 1942, first deliveries were not made until the late summer of 1942. The Register of Prices Paid mentioned above show no deliveries as of August 20, 1942. The order for 60,000 was completed around March or April of 1943, but because of the difficulties involved, they and the Ordnance Department agreed not to extend the contract. Wilde was producing other hand tools which were needed in industry, and the bayonet contract seriously interfered with their ability to make their regular product line. They also had a later contract with the Navy for hand pliers

The bayonets appear roughly made, as Wilde's machinery was not set up for this type production and finishing, but they were serviceable. The low contract price probably also meant that Wilde could not spend much time on final finishing. The marking used in 1942 is crude in appearance and used the older style Ordnance Shell and Flame with the flames separated at the top. The 1943 mark is neater in appearance and uses the shell with the flames coming to a point that is common for World War Two. Red grips with a black center panel are most commonly associated with Wilde production. These grips are unmarked on the inside.

M1905 Bayonets Being Sold By IMA

My thanks to Dick Newcomer who was kind enough to send one of these for my examination and sold it to me for my reference collection. It is marked with the standard US and Ordnance Shell and Flame, but the maker is M.D.C.O, obviously a fantasy item. One of the giveaways of these bayonets is a mark on the other side of the ricasso from the maker marks - a poor copy of the Ordnance Escutcheon that is found on some of the early M1905 bayonets made in 1942. This is sometimes called the crossed cannon mark, and on US made bayonets is often lightly stamped and hard to read. The mark on the IMA version is deeper and distinctly different from the regular mark. The internal design is similar to the US made M1905, but is cruder and shows evidence of quite a bit of hand fitting.

There have been 4 different markings reported to me so far on these bayonets. Two are fantasy markings, the M.D.C.O in an oval mark and a U.S.M.C. mark also in an oval. The other two are copies of regular US marks, PAL and OL. The PAL mark is fairly crude and should not be confused by anyone familiar with the standard marking. The oval around the PAL is closer to a circle, and the A in PAL is a totally different shape. The OL marking however is closer to the real thing and could be confusing. There are some minor differences when compared carefully, but nothing that really stands out by itself. Things such as the detailing in the flames, the shape and thickness of the line in the letters, and the 1 in 1942 can be seen to be different. Fortunately, at least on the ones I have seen, the reproduction of the Ordnance Escutcheon mark is so distinctive that there ought to be no problem in detecting the fakes.

THE BAYONET IS IN PERFECT CONDITION AND SHOWS AREAS OF WHERE THE PAPER AND COSMOLINE HAVE WORN OFF FROM TIME AND HANDLING. THE PHOTOS BELOW WILL SHOW THAT JUST ABOUT ALL OF THE COSMOLINE & COVERING STILL REMAINS, I MUST SAY IT WAS TEMPTING TO TAKE THE LAQUER THINNER TO THIS PIECE, BUT HOW COULD I EVEN CONSIDER THAT. THERE IS NO SCABBARD WITH THE BAYONET AS IT WAS NEVER IN ONE. YOU RARELY SEE A WILDE TOOL OFFERED FOR SALE, LET ALONE A TREASURE LIKE THIS ONE. THE ULTIMATE PIECE FOR THE MOST ADVANCED COLLECTOR.

After 17 bids, the winner paid \$585.75 for this M1942 Bayonet. I hope that it's still perfect after the Cosmoline is removed!
