

## January 2010 VGCA e-Newsletter



### Presentation at the December 3, 2009 Meeting of the VGCA:

The Speaker for the fourth and final VGCA/NFM Special Speakers session for 2009 was Mr. **Robert Dowlut**, General Counsel of the National Rifle Association. The



genesis of this presentation was the federal suit filed by the city of Chicago claiming that the Heller case (the DC Handgun ban case) only protects people living on federal enclaves or in DC, and does not protect the citizens in the several states. The Chicago case will most likely end up in the Supreme Court. Mr. Dowlut started his presentation with comments on language and specifically the related term in the law and Constitution of “the people,” and whether it means the ‘collective of all’ in federal precedents. He then covered the various levels of how a law is struck down or held unconstitutional. He discussed where a state constitution contains a right to bear arms and the implications if a state does not have such a specified right. At present, 6 states do not have a state level right, and a few others are minimal. He reviewed a history of selected litigation and the importance of carefully selecting the right cases to establish a clear precedent under the law. After the main

presentation, he took questions from the audience, including one on whether any international treaty or agreement could jeopardize US 2<sup>nd</sup> Amendment constitutional rights. According to Mr. Dowlut, the Constitution trumps treaty and has been addressed in two Supreme Court decisions. It was a very interesting presentation and very timely. (Members are encouraged to read an article on this case in the December 2009 *American Rifleman*, pp. 16-18.)

**★ UPCOMING Meetings:** On January 28, 2010, for our first meeting of the new year, the speaker will be **Homer Brett**, a noted researcher of military blades and bayonets from all nations. He has written a wonderful book on this subject *The Military Knife and Bayonet*, originally published in 2001. Members may wish to bring in all bayonets and military knives. **Comments from the Podium:**

Before the issue could be discussed, **Rick Nahas** also offered to match any VGCA donation. The Association, in keeping with its prior support of youth shooting activities and the Trigger Time group, made a donation to the group. This was a very worthy cause to ensure youth are exposed to positive activities and experiences with firearms. **Emory Hackman**, Election Committee, provided the membership with the results of the officer candidate search and asked for any additional nominations from the floor (see Announcement below and in Addison's comments). President **Addison Hurst** also congratulated **Rick Nahas** on his masterful stewardship

and hard work coordinating the gun shows, including selling tables, and all the other details that ensure success. A hearty hand was delivered by all in recognition of Rick's work.

☆☆☆ **Upcoming Election of VGCA Officers:** As mentioned in Addison's *Comments from the Podium* above, it is time for the election of the VGCA Officer positions. The Officers and Board ask that members think long and hard about what you would like to see from the club, what directions we should take as an organization, and who you believe would best serve and lead the club. Not all of the current officers will be running and we need, as does any organization with elected leaders, to have individuals who are willing to serve. **The January 28 meeting will be the last chance for nominations from the floor.** If you wish to run or would like to nominate a member for an Officer position, please contact Emory Hackman at the contact points listed above, or nominate them from the floor at the meeting. **Nominations will be formally closed, the candidates will be announced at the meeting and the ballots and Candidate statements will be sent a few days later. Please carefully review the ballots and return them ASAP.**

**December 3, 2009 Show and Tell:** Show and Tell kicked off with **Ed Costello** displaying a second year production, vintage 1904, US-marked Browning A-5 with 20" barrel. He relayed how this "rusty old gun" had survived a fire during its long service life. **Larry Hare** went on to share his long sought 3<sup>rd</sup> variation Mk III Webley Air Rifle. The .22 caliber pellet rifle was made from 1947 until 1975 – a long production run for this high quality British gun. **Addison Hurst** showed a varmint rifle made from a Springfield M1903A1 action. This heavy barreled traditional varmint rifle had a Unertl 15X Programmer scope, which was state of the art when it was made and is superb on this accurate rifle. **Bob Sears** showed some rare fine-adjusters for the M1903 Springfield rear sights that were used in match shooting. These tools, made by P.J. O'Hare allowed micro-adjustments of the sight for precision zeroing. He also discussed other micrometers, verniers, and other fine adjusting sights, adding his unique combination of history and personal experiences as only he can. **John Morris** displayed a Howard F. Brown-owned 1/12<sup>th</sup> scale model of a Consular Fortification Cannon that was used in Algiers. The cannon acquired its name from an incident where the Dey of Algiers, wishing to make a strong diplomatic point, strapped a French Consul onto the original cannon's muzzle and fired the cannon. This last historical anecdote closed the December meeting of the VGCA.
