



Meeting Show and Tell: Bob Sears opened up with a very nice Shattuck Arms Company single-shot break-open shotgun dating from the 1890's. Bob went on to tell the group how this particular shotgun was originally owned by a friend of his father, that he had acquired it at a very young age. Next up to the plate was Ernie Lyles, just back from a trip to Louisville, Kentucky where he had an opportunity to tour the Frazier Historical Arms Museum. According to Ernie, who is alleged to not be easily impressed, it was quite a display, including one of Teddy Roosevelt's Holland & Holland double barrel shotgun. Roger Sherman presented an awesome collection of three original pattern Swiss Lugers in exceptional condition. The first was a DWM Swiss military contract Model 1900 with the rare wide trigger, the second was a DWM Swiss military contract Model 1900/06 and the last was a Waffenfabrik Bern manufactured Swiss Military Model 1906/24 1st variation. Truly spectacular! Elmer Alsey

(sp?) brought out a "one of a kind" Ruger MK 1 clone built by PAWS with an integral silenced barrel. Apparently a small number were made up for a movie scripted around an assassin and all but one, (this example), were subsequently destroyed. John Morris is a big guy, and he collects big stuff. Consequently, he described his recent acquisition to the gathering, which consisted of an 1880's Navy breech loading boat howitzer. He would have brought it in, but it was too big, and too heavy (800lbs.) to bring into the building. It was still loaded in his van out in the parking lot and he did show it off to all who were interested after the meeting. Rick Nahas showed us a copy of his "Standard Catalog of S&W," now in its 3rd edition. It's been much more popular than he had originally anticipated when he collaborated with Jim Supica in the writing years ago. Marc Gorelick presented his Springfield musket with a .58 rimfire Miller Conversion manufactured between 1865 and 1867 and used by the Maryland and New York state militias. Larry Hare pulled out a Mossberg Model 144LS that he recently acquired. It was an example of firearms that are becoming very popular among new and older collectors, that are still readily available, and at a reasonable cost. Addison Hurst presented a late production (1918), all original; Model of 1917 Enfield rifle in exceptional condition, complete with an Model 1917 bayonet of course. This was another varied and fascinating grouping of arms and thanks go out to all who participated.

Member Notes: The following was received from LTC Christopher Smith (edited for space):

First I'd like to tell you all how much I enjoy receiving the newsletter each month - I always forward it to my friends and co-workers and they enjoy it too. However, as some of the folks know, I was mobilized (USAR) this past summer - so I won't be able to attend in person.

I have had a fairly unique tour over here in Theater thus far. It has allowed me to see quite a bit of what is going on. In early July 2006, I was posted to Camp Arifjan, Kuwait as the Chief of Current Operations for Deployment/Redeployment Operations. We shepherded 30 Brigades (15 in, 15 out) into and out of Theater as part of the annual rotation of forces. As that task was winding down for the year (before the latest surge plan), I was able to get an assignment with Task Force 586. TF 586 is based in LSA Anaconda, Iraq, we're about 50 miles north of Baghdad, near the city of Balad (in the Sunni Triangle). Our mission is to recover all surplus/excess vehicles, equipment and supplies in Theater and get them back into the supply system for re-issue and/or repair. With 30 BDEs swapping out equipment, trading gear, and moving around the battlefield there is "stuff" scattered among the various Forward Operating Bases (FOBs). We're sort of the clean-up crew. In early November I was selected to lead the TF 586 effort in Afghanistan and moved to Bagram (an air base about 15 miles north of Kabul) to take over operations here. I have been earning my C-130 and C-17 frequent flyer miles! One nice thing about Afghanistan (besides the fact that the mortar and rocket attacks are less frequent) is the opportunity to visit some of the Afghan arms bazaars - mostly junk but a few potential gems.

All in all, I am very proud to report that wherever I have traveled the morale and spirit of the Troops (Army, Marine, Air Force and Navy) has been magnificent. I have also found that the closer to the cutting edge - the better the morale. I don't know yet when I will be rotating back home - sometime this summer or fall I hope. But until then, a hearty thanks to you folks that are keeping the club together, making the shows happen, your actions reverberate beyond your immediate surroundings and is appreciated.

Con Rice: Michael Rice achieved his Eagle Scout Rank on Friday, January 26, 2007. Michael's Eagle Leadership Project was the creation of a rest area on the W&OD Trail in Purcellville where he coordinated the planting of 37 large trees and the construction of a 10 x 16 foot deck with benches and a ramp leading to the trail.

Legislative Alert: The following came to us via the Trapshooters.com forum. "The Democrats are not wasting any time. Regulation to include background checks of private sales is no doubt a part of this although it is not specifically mentioned here. This would probably impact informal club swap meets too." We strongly encourage our membership to contact their elected representatives, especially Tom Davis, and express their feelings on this recently introduced legislation.

The most Draconian bill thus far, though, is "The Gun Show Loophole Closing Act of 2007," H.R. 96 (<http://tinyurl.com/2m8vmr>). Says Alan Korwin of HR 96, "Under the original draft, currently legal gun shows are outlawed without prior federal permission. Gun show promoters must agree to warrantless searches in order to operate, and may be arrested if private citizens talk at the show about gun sales they wish to complete away from the show. The right to assemble peaceably at a gun show or even plan for one, carries stiff prison terms unless

federal licenses are issued in advance. Massive new bureaucracy is created because all shows and their exhibitors must be registered 30 days before the show, then again 72 hours before the show, and again five days after the show. That's in addition to registering anyone who walks in, plus 'any other information' the Secretary of the Treasury decides, by regulation, is necessary on vendors, attendees, and the show itself."

VGCA Welcomes New Members: Larry Hare welcomed new club member William Alexander after being soundly grilled and voted in, and **reminded annual members that dues ARE DUE NOW and they can be paid directly, in person thus saving the club printing and postage costs.**

All concealed weapon carry requests for the upcoming VGCA Gun Show **must be made by February 25th or they will not be granted.** Email your request with a reason for your request to carry and a statement that you hold a valid Virginia Concealed Weapons Permit, or you are an active or retired law enforcement officer, and a member in good standing with VGCA to ldhunt@idsscan.com. Anyone not appropriately registered before February 25th will be asked nicely to remove the weapon from the building.

It is especially important that we highlight the fact that we are a totally firearms related, quality show. There are no jewelry tables, no Beany Babies, no junk and no other fooferall items at the VGCA shows, and the displays are well conceived and top notch, often with rare and unusual items, but always with a goal of educating and informing the public and members of the history, technology and nostalgia of the period covered.

Future VGCA Show dates: Future dates for Fall 2007 are September 22-23, 2007. This includes the setup date on Fridays, September 21, 2007. That is plenty of time to plan and design a display table of your favorite firearms field.
