## February 2014 VGCA e-Newsletter



**Presentation for January 23, 2014 Meeting: Doug Wicklund**, Curator at the NRA National Firearms Museum (NRA-NFM) was the featured speaker for the meeting. His presentation covered the new *National Sporting Arms Museum*, a joint effort by the NRA-

NFM and BassPro Shops in Springfield, Missouri. The talk was accompanied by a great series of photos of this



new, impressive tribute and exhibition of sporting arms and accoutrements, artwork, advertising, and memorabilia from arms makers from the colonial era to the present. Here are a few examples, most of which were well documented by the photographs projected on the screen. The Museum has President Alexander Hamilton's Powder Horn, the Pachmayr Collection of superior firearms, and a 16<sup>th</sup> century (1500's) 16 shot wheel lock, with matchlock backup repeater... (© now that would be a treat to see in action). They have a staircase of rifles where the rifles serve as the posts for the railings, former NRA President and WW2 fighter ace Joe Foss's guns, and an original Armalite AR10 rifle from the 1950's. Even though this is a sporting arms museum, there are a number of military rifles on display including many of the national match rifles and pistols used over the years by famous marksmen in the National Matches at Camp Perry. Since this is a joint effort with BassPro Shops, the store's founder's gun is exhibited. One feature

that ties many of the different exhibits together is the Timeline of Guns, which covers weapons through history – and had a lot of space for the future – if we as citizens and gun owners remain dedicated to both the present fight and the future by passing on our passions and knowledge to the younger generations so they too can work aggressively to protect our firearms rights.

Included are a Lewis and Clark 1803 rifle and a Giardoni air rifle like the one used on the expedition, and an original Hawken half-stock plains rifle (very, very few original, working Hawken rifles survived their hard lives in the mountains). The Trap Shooting hall of Fame exhibit is also hosted in the museum, along with 2 of Annie Oakley's shotguns. For Old West fans, they have John Wesley Hardin's Colt double-action revolver and others. There are guns from the Remington Arms Company of Ilion, NY Museum, as well as original artwork that Remington Arms used in advertising and their famous calendars. We had a large turnout of members and were also provided with even more information by **Jim Supica**, Director of the NRA-NFM, who covered some of the many features and provided anecdotes on the design and development of the facility. This was a great presentation about an outstanding venue of which both the NFM and BassPro Shops are rightly proud, and to have such a cooperative effort by a business and an organization with long histories of facilitating the enjoyment and use of sporting arms, demonstrates what is possible. According to **Mr. Wicklund**, in the 4 months that the new facility was open in 2013, the new Museum had over 3 times as many visitors as the NFM had that same year. Both of our speakers and hosts did a great job, and a number of members remarked that the new *National Sporting Arms Museum* was going to be a destination at some point. After the presentations were concluded, those present were treated to a private tour of the Robert E. Petersen Gallery at the NFM.

☛ **Presentation for February 27 – Shannon Zeigler** will cover “*Japanese Type 99 Short Rifle Inspection Marks*” This will be a very informative program with some new material assembles from the study and observation of many

rifles. Shannon presented once before, but we had a computer snafu which precluded his illustrating his talk. That will not be a problem this time. We will have the new VGCA laptop and camera for showing details. (Note: LTC Gregg Thompson has been re-scheduled to the October 23, 2014 meeting.)

I hope everyone survived the recent show storms and enjoyed some quiet reloading time during these winter months. We have had some speaker shuffling to adjust to moving schedules. This month at our February 27 monthly meeting, Shannon Zeigler will present on Japanese Rifles.

I have a nice Mauser 98K re-chambered from 7.92 x 57 (8mm Mauser) to 7.92-06 (8mm-06), a common action done to thousands of WWII Mausers to take advantage of plentiful .30-06 brass, so I have purchased a box of 8mm-06 ammo to give with the rifle, an easy loss leader to make selling the rifle easier. I recommend this same example to all of you for the less common calibers.

**Show & Tell for the January 23 Meeting**: There was a lot of variety in the Show & Tell this evening. **Member 1** showed a Mossberg MB42 that was one of 50,000 .22LR training rifles made for the United Kingdom during WW2. These rifles that were sold as military trainers will show serial numbers, and those destined for the UKL will show British proof marks. This rifle, originally a Mannlicher stocked piece, had apparently been modified in the UK by replacing the full stock with a Mossberg sporter-type of stock. **Member 2** showed a very nice Swedish 1896 Mauser CG-63 Match Rifle. These were made from original Swedish 1896 Mauser long rifles, from a pattern designed in 1963 by the Carl Gustaf factory, hence CG-63. The changes included restocking in a heavy target stock

with raised cheek piece, installing front and rear diopter target sights, and rebarreling with a medium or heavy match barrel to take full advantage of the inherently accurate 6.5 x 55 Swedish military round. **Member 3** brought a Browning BLR prototype lever action rifle in .243 made by TRW. These were made to try US manufacturing, but the results were not acceptable to Browning, so manufacturing was done by FN, the traditional manufacturer of Browning long arms at that time. Manufacturing was later moved to Miroku in Japan. The final item of the night was shown by new **Member 4**. He displayed 1842 MP Ames percussion Naval Pistol in fine condition. He also displayed a flint lock piece in relic condition that he obtained in Haiti. Close examination showed it to be from an 1809 British Brown Bess India Pattern Type 2 Musket. If only it could tell its history.




