## June 2013 VGCA e-Newsletter



**Presentation from the May 23, 2013 Meeting: John E. McCullough, Esq.**, a new member of VGCA, gave an overview of “Gun Trusts” and the applicable laws such trusts are intended to address. This is a field that has been primarily of interest to holders of Class III weapons, but has generated lots of interest lately with estate planning. He addressed the two primary sections of Federal Law, Title I, the Gun Control Act of 1968 (GCA 68), and Title II, the National Firearms Act (NFA) of 1934 which covers “NFA firearms” (Class III machine guns, short-barreled rifles and shotguns, suppressors or “silencers”, etc.) He touched upon transfers of weapons (both NFA and non-NFA, and how important it is for every law-abiding gun owner or collector to stay abreast of all the complex and evolving gun laws. He explained the term “prohibited person” and how transfers to or allowing one access to a firearm could result in a criminal violations. , can create legal risks that you can avoid. He gave examples of how a well-crafted “Gun Trust” could enable passing down of guns to one’s heirs or purchasing NFA firearms without the consent of a local chief law

enforcement officer. This was an overview, but was still a detailed presentation with a lot of issues for consideration. As all cases are different, members wishing to carefully plan for the future should consult with knowledgeable legal advisors and planners. **VGCA Supports Youth Shooting:** VGCA President David Litchfield attended the Trigger Time 4-H Shooting Club weekly practice at the PWC Fairgrounds on Monday, June 3. He made a presentation of a check from the VGCA to the Club for \$1275.00. This will be used to purchase 3 Crosman 1701P Pre-charged Pneumatic (PCP) Target Air Pistols and Williams aperture sights for their Club to augment the 2 that they received from Crosman's youth developmental shooting program. These pistols are a relatively new product from Crosman built entirely in the U.S and have been very well received by the airgun competition community and provide many of the features are far more expensive European target pistols at cost that is affordable for new shooters exploring the world of precision airgun target pistol shooting. After the presentation, the 4-H club entertained a motion to spend the money to buy the three air pistols, with sights that we had approved. Dave spoke for a few minutes about VGCA, invited the shooters to attend one of our meetings and offered to give the 17 year old president a free one year membership in VGCA.



**Show & Tell at the May 23, 2013 Meeting:** S&T was quite varied this month. **Member 1** displayed a relic condition Civil War carbine missing many of its parts. Examination showed it was a Smith carbine. He sold the gun later in the evening to a fellow member for parts. He also showed a S&W Model 1, 3<sup>rd</sup> Variation in .22 short chambering. **Member 2** presented a new Taurus 992 double action revolver. The revolver is a 4” stainless steel model featuring a push button quick release to allow interchangeable .22 Long Rifle and .22 Rimfire Magnum cylinder and crane assemblies. While interchangeable cylinders are common on single action revolvers, it is unusual on a DA revolver, especially at a popular price point. **Member 3** showed his newly acquired CG-63 Junior target rifle. Based upon a Swedish Model 1896 or 1894 Mauser action converted to .22LR, these rifles were used to allow a shooter to develop skills with a low recoil .22, before transitioning to a full power 6.5X55 cartridge. The rifles were also used in indoor reduced range matches during the winter. **Member 4** presented a “bucket list” rifle, a very nice Marlin Model 27S pump action rifle chambered in .32-20 with an octagon barrel. This model was in production from 1909 to 1932, with this rifle made between 1913 and 1922. **Member 5** showed a large powder tank for 16” battleship guns. It is made of aluminum, and holds 300 pounds of powder in 3 100-pound bags. The standard U.S. Navy load for the 1800 lbs. 16” projectile was 600 pounds of powder. With this last item, the evening’s meeting of the VGCA concluded.


