## September 2009 VGCA e-Newsletter



**Presentation at the August 27, 2009 Meeting of the VGCA:** Phil Schreier of the NRA National Firearms Museum (NFM) kicked off the second of this year's NRA-NFM/VGCA Special Speaker series with the introduction of NRA General Operations Executive Director, **Kayne Robinson**, NRA Secretary Major E.J. Land, Jr., and **Jim Supica**, Director of the NFM. He then introduced Colonel **Oliver "Ollie" North**, a member of the NRA Board of Directors, by reviewing his decorated service record and background. Col. North then discussed his latest book, *American Heroes in the Fight against Radical Islam*. CSPAN Books was present to tape the presentation for broadcast, as well as [NRABlog.com](http://NRABlog.com) for future presentation. Prior to the meeting and his talk, Col. North had been signing books at the Museum for a long line of admirers, many who had bought multiple copies of the book as gifts. The book is a moving tribute to our men and women at arms – the modern heroes from the military branches and National Guard, who are on the front lines against terrorism and radicalization. He made a number of solid comparisons with the legacy of what was called the "Greatest Generation" of World War II, especially as the program was taking place near the 67<sup>th</sup> Anniversary of the First US land engagement in the Pacific – Guadalcanal. He also contrasted the main stream media (MSM) coverage of war and US troops, and how since the Vietnam era, the media has obsessed and condoned an anti-

military bias. He also showed numerous photos of US forces in theater from his prior tribes as a Fox Network reporter visiting Iraq and Afghanistan. All in all a moving tribute to the 1.6 million who have served. At the conclusion of the talk, **Addison Hurst**, President of the VGCA, presented Col. North with an Honorary Life Membership in the VGCA for his service and as a front-line defender of the Second Amendment. A short Q&A session followed before Col. North had to leave to catch a flight to Afghanistan. **Jim Land** was the second featured speaker and covered the latest USMC sniper rifles (some prototypes of Rem 700s used in the USMC sniper rifle trials) as well as his new special acquisition, one of the test rifles that had been prototyped and used to develop the USMC M40 during the Vietnam era. This rifle had been located with the help of VGCA member **Karl Karash**. Following the talk Maj. Land was also presented with an Honorary Life Membership in the VGCA that was 10 years overdue. This was followed by a moving presentation of a Colt M1911 pistol that was originally shipped to the USMC in Philadelphia, PA on December 5, 1917 to Maj. Land by Karl Karash and Nathan Babcock in the memory of his father Joel Babcock, who had always wanted to meet Maj. Land.

**Comments from the Podium:** The August meeting was, perhaps, one of the high water marks of meetings we have held in the past 25 years or so. To have speakers like Ollie North and Jim Land at a small gun club meeting, at the same time, is a rare situation indeed. The crowd was huge and if you missed it, well, that is your loss. Reliable reports indicate that a record 32 pizzas were quickly consumed. We need to have a business meeting this month since we did not have time for any of this at the August meeting. We need to fine tune the details of the show and discuss the possible field trip to the George C. Marshall Foundation trip. Don't forget to bring in stuff for show and tell. There have been some interesting things showing up recently. Please remember to tie or insert wire ties in the chambers of all arms brought in. Wire ties are always provided. Will have show flyers to distribute as well. Keep in mind that display tables for the fall show will be free. Contact Rick and reserve tables. We will have a sign up list for security duty at the show. Larry Hunt will need lots of help.

**August 27, 2009 Business Meeting:** The business meeting was brief due to the two special presentations and the hour. Guests in attendance were introduced and the **Larry Hare** informed that the following new members were voted into the Club: **Greg Bednarz**, **Jack Timmes** (Addison's eye doctor) and **Lance Simons** (please pardon the spelling, but due to calligraphy issues, the spelling may be wrong). Welcome aboard!

**August 27, 2009 Show and Tell:** After a stellar presentation series, and in spite of the stifling heat due to the large crowd, the Show and Tell continued to reveal numerous treasures, rare pieces and favorites, as well as the newest long sought after items. **Karl Karash** showed 2 factory documented 1935 Persian Contract Luger Pistols. While Persian Contract Lugers are relatively rare, and factory cutaway Lugers are even scarcer, to find a documented and serial numbered cutaway is an incredible prize. **Bill York** then gave a brief description of his small collection of foreign military revolvers that can be field stripped. Examples included a French 1892 service revolver, a large Austrian Rast-Gasser, one of the original barn door side plate revolvers, and the ubiquitous Russian Nagant revolver, a revolver that is very common due to the recent importation of millions of refurbished former Soviet surplus. Finding an original example like the one shown is now difficult. **Jim Vaughan** of Potomac Arms Collectors (PACA) showed his Remington 700 USMC Commemorative M40 that was released in limited numbers a few years ago. Going conventional on us, **Ernie Lyles** displayed a pistol that did not have rocket propelled bullets. It was a beautiful full custom M1911A1 .45ACP pistol. **Jack Looney** showed his new FNAR Tactical Rifle, with a fluted heavy barrel, in .308 Winchester. The rifle also had a Nikon 4-16x40 scope with mil-dot reticle on Leupold QR mounts, a 20 Round Magazine, and a Bipod and Sling. **Addison Hurst** presented a .308

Savage 110 with Accu-trigger and synthetic stock that is reputed to be a tack driver, a description that these Savages appear to have earned. The Show and Tell was closed by **Steve Philippi** who brought 2 original under hammer percussion rifles from the New England area. These rifles were popular as game rifles in New England since the hammer and nipple was on the bottom of the rifle affording some protection to the ignition system in foul weather.
