The History of Japanese Rifles the August 22, 2014 Meeting: Dave introduced Ret. LTC. Shannon Zeigler, who had done a presentation a few months ago on the inspection marks of Japanese rifles. He started off with a quick review of Japanese Rifles which are essentially Mauser style rifles, with a bolt action and a five round box magazine. Then he reviewed all the meanings of the markings and inspection stamps on the Japanese rifles and he got into some of the differences between the different models of the Arisaka.

The Type 30 bolt assembly has 10 pieces. In order to disassemble it, you have to take the bolt off, then push a piece up using a special tool, then it splits, and if you don't know what you're doing it goes everywhere and its very fragile so it could break. In the Type 38, they went to a very simple 5 piece bolt assembly. It can be taken down in no time and it is a very robust strong system and very simple. The Type 38 rifle is essentially an improved model 30 with better floorplate, a follower, the simplified bolt, and a different contour on the receiver. Early Type 38s were matched by assembly numbers rather than serial numbers though often the floorplate mismatched since they would fall out. This issue wouldn't be fixed until the Type-99 when the floorplate became hinged to the receiver.

The next subject was on the carbine versions of the Japanese rifles specifically the Type 38 and 44 carbines. The 38 carbine is a short 38 rifle, and the 44 has a built in pigsticker. The one sided wear on used 44s was often from being slung across a soldier's back, or from being worn across the back of a horse. The 44 carbines were made with 3 bayonet housings. The first variation is shorter, fragile, and often broke the stock when used. The second is larger, and the third is even bigger, and has a small protrusion. The second variation is least common, so is more of a collector's item. They only made about 100000 44 carbines, so they are fairly rare to start with. The 44 carbines have built in butt stock stowage and are the only Japanese rifle that has stowage in the buttstock.

The Japanese began looking at changing from the 6.5 to the 7.7 with the idea of having something a bit bigger and having a common size round between their guns. This however didn't work out as the war progressed and need for production was too high. The Type 92 had a small semi rim that was something that helped distinguish it. Most ammo you find that looks like Type 99 ammo is likely Type 92 and is fairly collectable and not the best idea to shoot due to questionability of the powder and corrosiveness.

The Type 99 rifle was heavily produced with roughly 2.5 million of them produced in near endless variations. For more details on the Type 99 reference the newsletter write-up from Shannon's presentation earlier this year. On a rarer level are a few rifles such as the Type 97 sniper and the Type 99 sniper which were specialized in their uses. An additional specialized rifle manufactured during the war is the T-2 Paratrooper rifle which had a screw piece that allowed it to be quickly broken down into two. This design allowed for the rifle to be easily stored in the backpack during drops and quickly assembled on the ground.

Shannon wrapped up his presentation for the night with a detour from the different models into a talk on the accessories associated with them. Muzzle covers are an interesting accessory to have and early brass ones are hard to find while steel and plastic are more common. The cleaning rods also evolved and changed with the rifles, becoming more and more flush and out of the way. Japanese bayonets are a collector's item as well and in a way there are only really two types to try and collect - one with a hooked quillion and one with a straight quillion - though in reality there are hundreds of variations. Those are the primary differences.

OUpcoming Presentation for September 25, 2014: This September Addison Hurst will be treating us to a presentation on "*The Kalashnikov Rifle and Legacy*". Newly Adopted Proposals by the Board: Proposal 1 was to establish a relocation committee to start the process of identifying a possible new location for the gun show. Proposal 2 set aside and sequestered a separate line-item account funds for the possible future relocation and start-up of the gun show in a new venue. Proposal 3 was a nine-part Policy on Contributions/Donations to Organizations. Having a general Policy will make the contribution process more efficient and effective.

Part 1 – The Vice-President of the VGCA is in charge of the process for contributions/donations.

Part 2 - The amount of contributions to organizations, programs or activities in any one calendar year is not to exceed 10% of what we have in the treasury. Not to include the funds sequestered for start-up funds for a new gun show venue.

Part 3 – The limit on contributions applies to all groups together.

Part 4 – The Vice-President, in consultation with the Treasurer, will prepare a budget for contributions/donations no later than April 15. The Vice-President shall solicit funding requests early each year.

Part 5 – Gifts to organizations/programs/causes or activities should be once per annum.

Part 6 - Donations/contributions to the NRA are their own line item within the amount budgeted for

contributions. Donations to the NRA Museum and Foundation should have general preference over all other donations or gifts and should be voted on before any other contributions.

Part 7 – Contributions/donations for gun collecting and gun history educational organizations, causes, programs and activities, and support for the 2^{nd} Amendment, have general preference over contributions to support non-gun collecting related organizations, programs and activities.

Part 8 – The Board of Directors will discuss, consider and vote on all contributions/donations during a formal meeting of the Board. Requests or solicitations for donations should in the form of a written request. The Vice-President of the VGCA will decide what information the requests should contain.

Part 9 - In the event of an individual extraordinary case (solicitation for a contribution/donation), the limitations listed in the foregoing parts of the Proposal to Adopt a Policy on Contributions/Donations can be set aside only for that case by a formal majority vote of the Board of Directors. Amendment or modification of any of the foregoing parts of the Proposal to Adopt a Policy on Contributions/Donations can only be done by a formal majority vote of the Board of Directors.

The Relocation Committee: This is an "in-case of emergency" exercise. Identifying alternate new locations for the gun show will be a multi-year endeavor. The relocation Committee will be independent and will report its progress and findings periodically to the Board. Any VGCA member, including members of the Show Committee can serve on the committee and this should be encouraged. Board Member Marc Gorelick chairs the committee. If you want to help and be a committee member, please contact Marc.

Show and Tell

Member 4 displayed a Lee Enfield MK III produced in 1909 converted to a .22LR trainer complete with a rare Parker Hiscock 5rd. magazine. Only 5000 of these magazines were produced in 1913 and few remain because of their unsuitability for service.
