## September 2016 VGCA Newsletter

### ★ VGCA Meeting of August 25, 2016:

Our August presentation was from Emory Hackman on the topic of Guns of the Early Cowboy Era. The “Early Cowboy Era” is defined by the years 1868 (the year of the first major cattle drive from Texas to Kansas along the Chisholm Trail – which was itself aided by the Peace Treaty of Medicine Lodge signed with the Kiowa and other tribes the previous year - and the Transcontinental Railroad moving through the plains) and 1872 (when a railroad spur reached Wichita, Kansas). An economic panic in 1873 caused cattle prices to plummet and reduced the demand for future cattle drives. Emory did an excellent job of describing the economic status of cowboys and other frontier occupations of the day, to include the Buffalo Hunters.

If they carried a pistol at all, it was also in all likelihood a Civil War surplus revolver such as the .36 caliber Colt 1861 (below) or the larger .44 caliber Remington 1859 or Colt 1860.



Cowboys were not wealthy people as Emory noted, and often carried inexpensive weapons, such as the

Unlike cowboys, who used whatever firearms they could afford (preferably ones that were also cheap to shoot), the Buffalo Hunters of the period used the finest, most powerful weapons they could find (such as cartridge firing Sharps rifles). Hunting for buffalo hides could be very lucrative, with successful hunters making over \$1000 a month.



This was another outstanding presentation and was enjoyed by all present! On behalf of all of the members of the VGCA, thank you Emory!

★ **From the Membership Chair - Notice of New Annual Dues and Membership Renewal Procedures for Annual Members (Part 1):** Annual members should be aware that the membership renewal process and the payment of annual dues were revised this past December 2015 with approval by the membership of the new Virginia Gun Collectors Association, Inc. Bylaws.

According to the new Bylaws, ARTICLE III – Dues, Section A., the payment of annual dues is due by January 1 of each year. For 2017, the Annual Dues are due by January 1, 2017.

Section B. requires that there will be an Annual Member Dues Renewal Notices. The Notice and Form will be in both the mailed and emailed newsletters beginning with the October 2016 issue. Dues must be paid by the first membership meeting of the year (January 26, 2017).

Section C. provides, “in the event that payment is not received on or before the first membership meeting of the year, the member shall be deemed to not be in good standing, and shall not be eligible to vote or run in association elections, participate in Association activities, and shall forfeit his or her membership and may only regain membership as specified in Article II.” That means re-applying for membership. ### ★ August 2016 Show and Tell ★

Brian Pelton brought in his first-ever Curio and Relic purchase – a Carcano Type I made for the Imperial Japanese Navy (IJN). The IJN at the time was in direct competition with the Imperial Japanese Army for domestic small arms production, and with war on the horizon, the IJN was forced to look outside Japan to acquire weapons. With a rear half that looks like a Carcano and a front half that resembles a Type 38 Arisaka, approximately 60,000 to 120,000 of the Type Is were produced in 1938-39. Chambered in

6.5x50 Japanese, there is no record of these rifles actually being issued and they are often found in excellent condition. Brian picked up this specimen at a Dale City show about 7 years ago. He also shared an outstanding book on the subject entitled “Italian Small Arms” by Ralph Riccio. Published by Schiffer Ltd Publishing, it is “the definitive source for WWI and WW2 Italian small arms.



A member presented a Smith & Wesson “Lemon Squeezer” (aka the Safety Hammerless) chambered in .32 S&W. This double-action revolver that was produced from 1887 to 1940 and incorporated an internal hammer and an external grip safety on its back strap. This grip safety is how it earned the “Lemon Squeezer” nick-name. Also presented was his Richmond Arms 10 gauge “Coach Gun” which he had custom made by Cowboy Cody in Maryland for Cowboy Action Shooting.



One of our members, in keeping with the theme of the presentation, brought in three original Colt Navy Revolvers. They were a Model 1851 (7 ½ inch barrel), a Model 1861 (7 ½ inch barrel), and a Model 1865 (5-shot). The 1861 and 1865 were both made in their respective first years of production. These cap-n-ball revolvers fired a 126 grain .36 caliber conical bullet which was propelled by 15-20 grains of black powder. All three models were made until 1873. Among the accessories were a bullet mold, powder flask, nipple wrench, and screwdriver for the pocket Colt.



Bob Sears presented another rare and interesting firearm – this time it was a Winchester Model 54 “National Match.” Only produced in 1935 and 1936, this particular rifle has a serial number much higher than any other recorded and may be the last Model 1954 produced! Intended as an improvement over the Springfield Model 1903 for match shooting, this example is chambered in .30/06 (one of 9 calibers that the Model 54 was chambered in) and featured a Lyman 48 sight. And the wood on this gun, though cataloged as “plain” to denote no checkering, was beautiful.

Jim Burgess brought in his 1863 Sharps Percussion rifle converted with a barrel liner in 1868 to .50/70. It is an example of what a buffalo hunter may have used. Jim also provided several reproduction pieces to support Emory’s presentation.



A very nice Smith & Wesson K38 “Masterpiece” was also presented for show-n-tell. This particular

revolver was issued to USAF General Seth J. McKee. General McKee began his career as an aviation cadet in 1938, flew the P-38 “Lightning” in Europe during WW2 (where he was credited with destroying 2 enemy aircraft), and culminated his career as commander of the North American Air Defense Command from 1969-1973. This is a fine piece with an historic past!



Larry Hare brought in his reproduction Navy Arms Uberti iron-frame Henry. Chambered in .44/40, Larry acquired this lever action in 1995.

### **PACA SHOW REPORT – Small but Full of Treasures**

The Potomac Arms Collectors Association (PACA) annual show is small by any standard (about 60 tables) but is well worth attending. I manned the VGCA promotional table at the show September 10-11 in Frederick, Maryland. The PACA show is usually full of hidden treasures for the arms collectors and this show was no exception. Most of the tables are rented by PACA members who bring out items to sell from their personal collections. Many of them are nationally recognized experts in the arms collecting community with many years of expertise. In addition, the show also attracts dealers who are known experts in their fields. They are friendly, helpful and more than willing impart their considerable knowledge. This show is not for the modern black gun enthusiast. Rather the hall was full of wonderful historical arms, with a healthy percentage of guns, accessories and accoutrements ranging from colonial times to World War 2. Unfortunately, attendance was sparse as the show

conflicted with a nearby Silverado show. However, this only made table holders more willing to deal. A number of VGCA members took advantage of our arrangement with PACA for free admission to the show and I saw more than one VGCA member walk out with a holding a treasure and with a grin on his face. Those who didn't attend missed an opportunity to see some great guns and possibly find a gem for their collections.



## Museum

### A VISIT TO THE MUSEUM – THE SWEDISH ARMY MUSEUM

Located in the heart of the Ostermalm section of Stockholm, Sweden, the Army Museum, or Armemuseum, is a delight for the military historian or arms collector to visit. One of Sweden's best museums, it is also a world-class military and weapons museum. Its displays illustrate the military history of Sweden from the 1500's and the history of the Swedish Army. The Army Museum has been located at Artillerigården since it was opened in 1879 as the Artillery Museum. The site has been used for military purposes since the middle of the 17th century, and the main artillery depot was located there for nearly 300 years. The current buildings were erected during the latter part of the 18th century. During the 17th century the Swedes managed to gain control of parts of Norway, Russia, Estonia, Latvia, Lithuania, Finland, Poland and parts of Germany by conquest and sheer power. Sweden was one of the strongest European military powers during the Thirty Years War and the museum, on the whole, objectively depicts the both the horror and glory of that time. There is also a special exhibit about Raoul Wallenberg.

The many displays and dioramas take the visitor into the middle of battle and show the living conditions of the soldiers and their families during wartime and peacetime. They include life-size figures of soldiers of past centuries, as well as scenes of the major battles of Swedish forces, weapons, military clothes and other attributes of war. There is a special collection showing the trophies (including cannon) and flags of armies defeated by Sweden during its many wars during the 17th and 18th centuries. It was at this time that Swedish armies under King Gustavus Adolphus revolutionized European warfare. The museum is also unsparing in its depiction of Sweden's defeats, including those of the Great Northern War, during which it lost most of its empire.



For arms collectors, the museum's galleries house the most comprehensive collection of Swedish weapons in existence. The collection details the technological development of Swedish military firearms from the 16<sup>th</sup> century (matchlocks, wheel locks, snaphaunces and flintlocks) to the modern arms of today's Swedish army, including the AK-5 Assault Rifle version of the FN FNC. It also includes a number of unique weapons, including developer's models and prototypes, whether they went into production or not. Among these are the world's smallest automatic pistol. Many of the weapons on display can be handled by visitors. The Army Museum is open year-round and admission is free.
